

## 1820 District Bounds

#1 Beginning at the Southeast corner of the same at a stake & stones on Browns North Line so called being also the S.W. corner of No. 5 the NW corner of No 6 and the NE corner of No 7 from thence west 16°S on said Browns N line & by district No 7 & 8 to the Great valley Brook so called then Norhtwardly by sd brook to the Center of the bridge over the Same in the road leading from Charlton Center meeting house to Daniel Hathaways---then Northerly by district No 10 to a Chestnut tree marked at the S.E. corner of Jonathan Fullers land thence northwardly to the S.E. corner of the farm Capt Otis Farnum bought of Josiah Blanchard thence NEwardly to the N.W. corner of the land Joseph Peck bought of Widow Lucretia Belings thence northwardly to the S.E. corner of Elijah D. Spurrs farm thence NE to the SE corner of Capt Saml Ries (Kies) farm then S to a yellow oak tree marked at the corner of District No 4 & 5 then S to the bounds first mentiuoned.

#2 In 1820 report “(Formerly called Levi Davis’) Beginning at the SE of Saml Kies farm from thence W & Nwardly by the district No 1 to the NE corner of Danl Marbles farm on the Gore line so called thence N to a stake & stones 15 rods E of the E end of the dwelling house of Abner Wheelock 2<sup>nd</sup> thence due N to Spencer line thence E on Spencer line to the NW corner of Adam Wheelocks farm thence Swardly to the SW corner of Nehemiah Stones farm thence Swardly to the bounds first mentioned.”

#3 1820 report: “(NE Ward) Beginning at the NW corner of Adam Wheelocks farm on the Spencer line thence Swardly on Dist No 2 to the SW corner of N. Stones farm thence Ewardly on the Thompson North line s.c. to Oxford line thence Nwardly on Oxford, Gore, Leicester, & Spencer line to first mentioned bound.”

#4. 1820 report: “(Called Millward) Beginning at the NE corner of same at a stake & stones on Oxford line thence wdly on dist. 3 to the SW corner of N. Stones farm thence Swdly by Dist. 2to the SE Corner of Saml Kies farm thence S 18 west to a yellow oak tree Marked on the Thompsons south line so called, thence Ewdly on said Thompson line s.c. to Oxford thence on Oxf line to the first mentioned.”

#5.1820 report: “(Called E. Ward) Beginning at the NE corner of the same at the SE Corner of Dist. 4 on the Oxford line thence Wdly on dist 4 to dist no 1 thence Swdly on No 1 to Browns North line s.c. thence Edly on said Browns N line to Oxford thence Nwardly by Oxford line to the first mentioned bound.”

#6 1820 report: “Beginning at the NE corner of the same on Oxf. line thence westwardly on dist 5, #1 & 7 thence S 10 E until it strikes the brook on which the Sawmills of Rufus & John Mixer stands thence down said brook until it meets the brook running from Conant mill sc thence up said last mentioned brook to Dudley line thence by said Dudley & Oxford line to the first mentioned bound.”

#7. 1820 report: “(Called Amos Davis Ward) Beginning at the NE corner of the same at a stake & stones on Browns N line sc thence wdly on said line to a large Chestnut tree marked on the line btwn the land of John Fitts & William Foskitt thence Swdly to the barn of James Melenday, thence S 35 E to a Chestnut marked standing by the S side of the county road leading from Oxford to Southbridge thence due south to Dudley line thence Ewadly on

Dudley line to a Brook running from Conants Mill thence Nwdly by dist No 6 to first mentioned bound.”

#8. 1820 report: “(Called Southward) Beginning at the NW corner of the same at a large Chestnut tree marked by the land of John Fitts & Wm. Foskitt on Brown’s N. line sc & on dist. #4 thence w wdly on said Brown’s N line to the Great Valley Brook sc thence Swdly down said brook to the E side of said town road (*note: see dist 7 description*) until said brook crosses said road by Richard Dressers saw mill thence down said brook to Sbge line thence Ewdly by said Sbge by Dudley line to dist no 7 thence Nwdly by dist no 7 to first mentioned bound.”

#9 1820 report: “(Called S.W. Ward) Beginning at the NW corner of the same where Sbge line crosses the town road S of Wm. Bloods house thence Ewdly to the SW corner of Dist No 1 & NW corner of No 8 thence Swdly on dist No 8 to Sbge line thence Nwdly on Sbge line to the bound first mentioned.”

10. 1820 report: “(Called Rum Hill Ward) Beginning at the SW corner of the same being the NW corner of Dist No 9 to the SW corner of dist No 1 thence Nwdly by said No 1 to a Chestnut tree the corner of John’n Fullers land & of dist No 14 thence Swdly to the NW corner of John Browns land thence S to Sbge to town line to the first mentioned bounds.”

#11. 1820 report: “(Called Chestnut Hill Ward) Beginning at the corner of Stbge thence Ewdly to the NE corner of Johnathan Winslows land thence Swdly to the SW corner of Wm. Nichols land being the corner of No 10 thence Swdly by dist No 10 to Sbge line thence by Sbge line & by Sturb. line to the first mentioned bounds.”

District 12 1820 report: “(Called NW Ward) Beginning at Majr Danl Williams SE Corner thence Nly by Simon Wards N Corner on Spencer line thence by the lines of Spencer, Brkfld & Sturb to the corner of said Sturb and of Dist No 11 thence Ewdly on the Old County Road to a stake & stones E of Walter Merritts Barn thence NE to the SE corner of Abijahs Lambs farm thence northwardly to Isaac Williams NW corner thence Ewdly to the first mentioned bounds.”

#13 1820 report: “(Called Northward) Beginning at the SE corner of the same at the NE corner of Daniel Marbles farm thence Nwdly by dist No 2 to Spencer line thence Wdly on Spencer line to the NW corner of Simeon Woods farm thence southwardly by dist No 12 to the SE corner of Maj. Danl Williams farm thence Ewdly to the NE corner of Moses Williams farm thence Swdly to the NW corner of Daniel Marbles farm and No 1 thence Ewdly by No 1 & on the Gore line so called to the first mentioned bounds.”

#14 1820 report: “(Called City Ward) Beginning at the William Nichols SW corner also of district No 10 thence Ewdly by dist No 10 to a Chestnut tree the corner of Johanathan Fullers thence Nwdly by dists No 1 and 13 to the NE corner of Moses Williams farm thence Wdly to the SE corner of Majr Daniel Williams farm thence SW wdly by dist No 12 to a stake & stones the NE corner of Jona Winslows farm thence S wdly to the first mentioned bounds.”
